Course Descriptions:

Beginning Spanish-Introduces basic language concepts: Counting, colors, greetings and good-byes, snack vocabulary, body parts, active verbs and a few questions.

Beginning Chinese, Level One-Introduces basic language concepts in Mandarin, with the use of games, rhymes and skits. Culture will be introduced in each lesson as well as familiarization of the Chinese characters.

School Life Theme-For students who have already taken the Beginner course. A lively rap song takes children through all the steps of getting ready for school. Students learn to talk about their teachers, their school, and the objects in the classroom. Games like "Who's got the pencil?", "Who's calling you?" and "Around the World" give children an opportunity to use the vocabulary in fun ways.
